## WARRANTY

This limited warranty is given by Comfort Line limited, 5500 Enterprise Blvd., Toledo, OH 43612 to the entity named on the reverse side.

**Warranty Coverage and Duration** • CLL will replace any component of the product(s) listed on the reverse side which is defective in material or workmanship for the period of time indicated on the reverse side.

A copy of this limited warranty should be sent along with the claim request to verify records. Any components of the products supplied which are suspected to have imperfections must be presented within the applicable warranty period CLL, after repairing or replacing the component under warranty will ship the component at no cost to you.

**Warranty Does Not Cover** • This warranty does not cover damages resulting from accidents, alterations, failure to follow instructions, misuse (including failure to perform reasonable and necessary maintenance of windows). In addition CLL will not be responsible for any costs or damages with respect to the removal, installation or reinstallation of any window components or products.

This warranty does not cover damages to insulating glass units if the unit is mishandled or damaged during installation.

CLL does not warrant any units that have been altered in any way.

**CLL Will Not Do** • CLL will not be responsible for implied warranties, including those of fitness for a particular purpose and merchantability, for more than the applicable warranty period set forth above with respect to each component.

CLL will not pay for loss of time, inconvenience, loss of use of any component or product, or pay personal injury or property damage caused by any component or product or its failure to work or any other incidental or consequential damages.

This warranty sets forth all of the responsibilities of CLL regarding the components and products. Replacement of defective components at the CLL factory is the exclusive remedy. This warranty is the only one which CLL gives on components and products. There are no other express or implied warranties from CLL.

**Other Conditions** • This warranty will become effective only upon certification by our customer that the installation of the products has been completed at the address listed on the reverse side and is contingent upon payment in full to CLL for the products provided.

**State Law Rights** • Some states do not allow limitations on how long an implied warranty lasts or the exclusion or limitation of incidental or consequential damages, so the above exclusion or limitation may not apply to you. This warranty gives you specific legal rights and may also have other rights which vary from state to state.
